Landlord

Geethike Samaratunge (the 'Landlord') applied for an order to terminate the tenancy and evict Jefferson K McQuillan (the 'Tenant') and for an order to have the Tenant pay the rent the Tenant owes because the Tenant failed to meet a condition specified in the order issued by the Board on June 30, 2021 with respect to application TEL-12646-20.

Determinations:

- 1. The order provided that the Landlord could apply to the Board under section 78 of the Residential Tenancies Act, 2006 (the 'Act') without notice to the Tenant to terminate the tenancy and evict the Tenant if the Tenant did not meet certain condition(s) specified in the order.
- 2. I find that the Tenant has not met the following condition specified in the order:

The Tenant failed to pay to the Landlord \$6,000.00 on or before June 30, 2021 towards arrears of rent.

- 3. The previous application included a request for an order for the payment of arrears of rent. The resulting order required the Tenant to pay rent or some or all of the arrears of rent. Accordingly, in addition to eviction, the Landlord is entitled to request an order for the payment of arrears of rent and compensation.
- 4. The Tenant was ordered to pay \$11,450.00 for rent arrears in Order TEL-12646-20. The amount that is still owing from that order is \$11,450.00 and that amount is included in this order. As a result, the previous order TEL-12646-20 is cancelled.
- 5. Since the date of the order, the Tenant has failed to pay the full rent that became owing for the period from July 1, 2021 to July 31, 2021.
- 6. The Landlord collected a rent deposit of \$2,050.00 from the Tenant and this deposit is still being held by the Landlord.
- 7. Interest on the rent deposit is owing to the Tenant for the period from November 26, 2019 to July 19, 2021.

It is ordered that:

- 1. Order TEL-12646-20 is cancelled.
- 2. The tenancy between the Landlord and the Tenant is terminated. The Tenant must move out of the rental unit on or before July 30, 2021.
- 3. The Tenant shall pay to the Landlord \$10,633.99*. This amount represents the rent owing up to July 19, 2021, less the rent deposit and interest the Landlord owes on the rent deposit.
- 4. The Tenant shall also pay to the Landlord \$67.40 per day for compensation for the use of the unit starting July 20, 2021 to the date the Tenant moves out of the unit.
- 5. If the Tenant does not pay the Landlord the full amount owing* on or before July 30, 2021, the Tenant will start to owe interest. This will be simple interest calculated from July 31, 2021 at 2.00% annually on the balance outstanding.
- 6. If the unit is not vacated on or before July 30, 2021, then starting July 31, 2021, the Landlord may file this order with the Court Enforcement Office (Sheriff) so that the eviction may be enforced.
- 7. Upon receipt of this order, the Court Enforcement Office (Sheriff) is directed to give vacant possession of the unit to the Landlord on or after July 31, 2021.
